Brief discussions of legal analysis are included throughout, recognizing the interplay between research and analysis. California Legal Research supplements its primary discussion of state research with brief discussions of federal research. Thus, it can be used as the sole text in a research course or in conjunction with texts focusing on topical or federal research.
